

Preface from Concept Agrotech Consultants Ltd.




Feedback 1.1: The objectives of the training were clearly defined




Feedback 1.2: Participation and Interaction were encouraged




Feedback 1.3: The topics were relevant




Feedback 1.4: Content was organised and easy to follow




Feedback 1.5: Study materials distributed were helpful




Feedback 1.6: Training experience is expected to be helpful




Feedback 1.7: Trainers were knowledgeable about the topics




Feedback 1.8: Trainers were well prepared




Feedback 1.9: Training objectives were met



Feedback 1.10: Time allotted for training was sufficient




Feedback 1.11: Meeting room and facilities were adequate and comfortable




Feedback 2.1: Location of IARI was suitable for gaining agriculture exposure




Feedback 2.2: Visit has helped in gaining agri exposure substantially




Feedback 2.3: Various departments involved in training showed their interest




Feedback 2.4: Various departments visited were adequately communicated before




Feedback 2.5: Meeting rooms and facilities in IARI were adequate and comfortable




Feedback 2.6: Experience gathered from IARI is helpful for job and job targets




Feedback 2.7: Faculties within IARI were knowledgeable about topics




Feedback 2.8: Faculties within IARI were informed and prepared




Feedback 2.9: IARI visit objectives were met
